If the nomination contestant is not selected, any campaign funds held at the end of a campaign period for the nomination contest must be transferred to the registered party or registered constituency association for which the nomination contestant sought endorsement, or be returned to the contributors who contributed to the nomination contestant's campaign. Any funds not transferred, or returned to contributors, within 30 days after the day on which the nomination contestant campaign return is required to be filed must be paid to the Chief Electoral Officer for deposit in the General Revenue Fund.
