INTRODUCTION

PURPOSE OF THIS GUIDE

This guide has been produced to assist the political party chief financial officer (CFO) with the preparation of financial disclosure forms including the annual financial statement, the campaign return, and all applicable schedules.

This guide is intended to be used in conjunction with the <u>Political Party and Constituency Association Guide to the Election Finances and Contributions Disclosure Act</u>. All guides, registration and financial disclosure forms are available on the Elections Alberta website at www.elections.ab.ca.

Links to the *Election Finances and Contributions Disclosure Act* (EFCDA) and other relevant legislation are also available on the Elections Alberta website. Copies of provincial legislation may also be obtained from the Alberta Queen's Printer (www.qp.alberta.ca).

PUBLIC DISCLOSURE

All documents, including financial statements and registration documents, required to be filed with Elections Alberta by a political party become part of the public files and are available for public review. Financial statements are also posted on the Elections Alberta website at www.elections.ab.ca under Parties, Candidates & Contests / Financial Disclosure.

ANNUAL FINANCIAL STATEMENT

This section contains information to assist the CFO to prepare the annual financial statement. Under section 42(1) of the EFCDA, the statement must include the previous year's revenue, expenses, assets and liabilities of the registered party. Note: If a general election was held during the year, exclude from the annual financial statement, any contributions received during the campaign period, and any payments or transfers related to that election.
